EFFECT OF OVEREXPOSURE - INHALATION: Under normal use conditions, this product is not expected to cause adverse health effects. During application and cure, this product releases methanol. Methanol may affect the brain or nervous system causing dizziness, headache or nausea. EFFECT OF OVEREXPOSURE - CHRONIC HAZARDS: Repeated or prolonged exposure may cause mild irritation of eyes and skin. A mixture of diisodecyl phthalate and diisononyl phthalate has been tested in a two-generation toxicity study in laboratory animals. No effects on reproductive parameters were seen. However, a small but statistically significant increase in early offspring mortality was seen at high oral doses. The significance of this to humans is uncertain. Trimethoxyvinylsilane may cause heart muscle damage, anemia and lung, liver and kidney damage. Constituents of this product include crystalline silica which ,if inhalable, may cause silicosis, a form of progressive pulmonary fibrosis. Inhalable crystalline silica is listed by IARC as a group I carcinogen (lung) based on sufficient evidence in occupationally exposed humans and sufficient evidence in animals. Crystalline silica is also listed by the NTP as a known human carcinogen. Constituents may also contain asbestiform or non-asbestiform tremolite or other silicates as impurities, and above de minimus exposure to these impurities in inhalable form may be carcinogenic or cause other serious lung problems.
